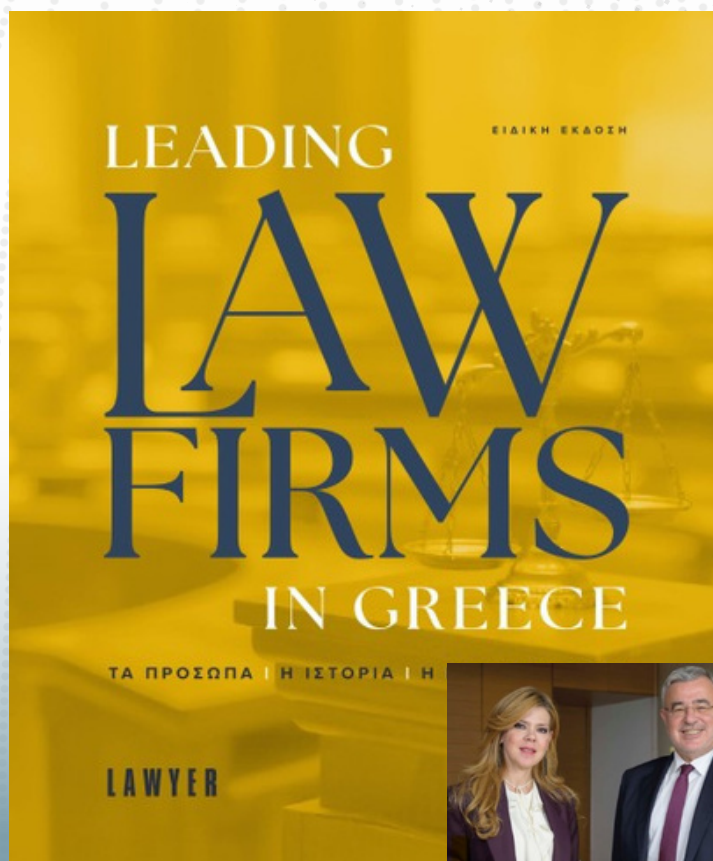

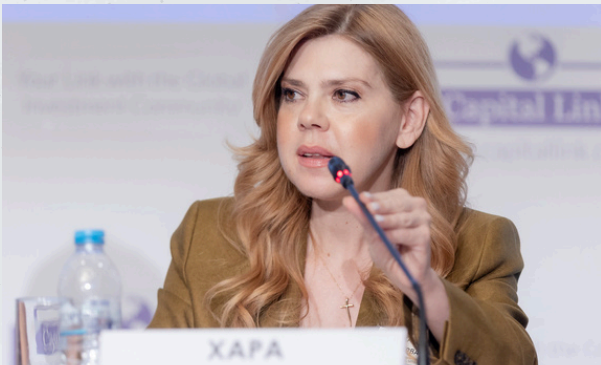

Για τη διασφάλιση της εξειδίκευσης πορείας της ανάπτυξης, ο αρμόδιος φορέας, η Enterprise Greece, θα ενισχύσει την διαμόρφωση και λειτουργία φορέων που, ενώ παράλληλα, οι επενδυτές πρέπει να προσαρμόζονται στις δομές μεταβαλλόμενης συνθήκης.

- Regulatory Obligations under the CSRD Directive.

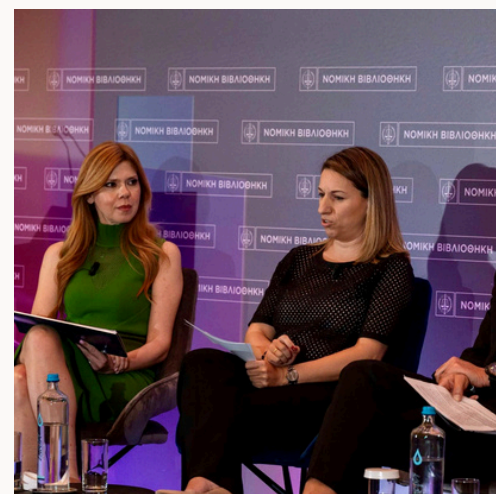
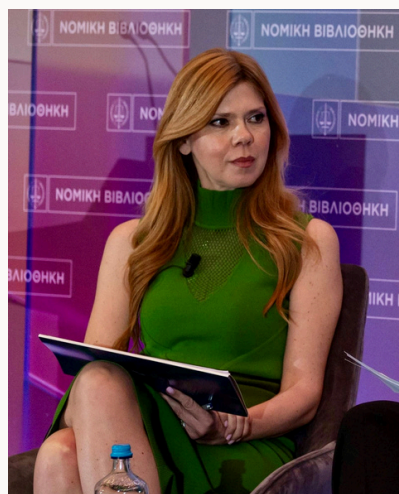

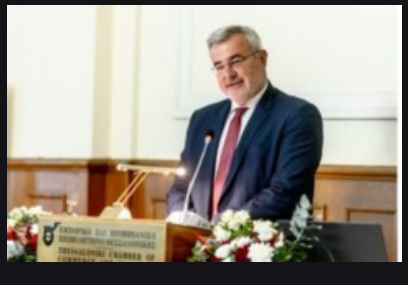
